

“Discover Canada” Contest (“Contest”)
Grand Prize Winner:
Declaration and Release

To: Parks Canada (“Sponsor”)

1. I (the undersigned) hereby understand, acknowledge and agree that before being declared the winner (“Winner”) of the Grand Prize available to be won in the Contest, I must and will sign and return this Declaration and Release form to the Sponsor within two (2) business days after receiving Sponsor’s notification of my eligibility to win and receive the Grand Prize.
2. I hereby:
 - a. confirm that I have complied and will continue to comply with the Official Contest Rules and Regulations, without exception or limitation;
 - b. declare, irrevocably, my willingness to accept the Grand Prize as-awarded to me;
 - c. understand, acknowledge and agree that the persons who are or will be my travel companions in this Contest will not, according to the Official Contest Rules and Regulations, be entitled to do so unless he/she signs and returns to the Sponsor the Sponsor-supplied Declaration and Release form for Travel Companions;
 - d. grant to the Contest Parties and the Released Parties (both terms defined in #3 below) full permission and consent to the publication, reproduction and/or other use of my name, address, voice, statements about the Contest, and/or the Grand Prize made by me, and/or photograph or other likeness of me, without further notice or compensation, in any publicity or advertisement relating to the Contest carried out by or on behalf of any of the Contest Parties and the Released Parties, in any manner whatsoever including, without limitation, print, broadcast, the internet, and social media;
 - e. agree that all the rights and releases I hereby grant to the Sponsor and to others are unlimited as to time or geography;
 - f. declare that I have done nothing and will do nothing to disqualify me under the Official Contest Rules and Regulations as the winner of the Grand Prize in the Contest; and
 - g. consent to the jurisdiction and venue of the federal, provincial and local courts located in the Province of Ontario for the resolution of all disputes with regard to this Declaration and Release except only that any litigation by residents of the Province of Quebec respecting the conduct or organization of a publicity Contest may be submitted to the Régie des alcools, des courses et des jeux, for a ruling. Any such litigation respecting the awarding of a Prize to any resident of the Province of Quebec may be submitted to the Régie des alcools, des courses et des jeux only for the purpose of helping the parties reach a settlement.
3. In consideration of being awarded the Grand Prize in the Contest, and without requiring additional compensation or permission, I hereby release, hold harmless and forever discharge the “Released Parties” (identified as such under Rule (j) of the Official Contest

Rules and Regulations) including (without limiting the generality of the foregoing) the Sponsor, the Prize Providers, and its and their associated and affiliated companies, distributors, and the advertising fulfillment, judging and promotion agencies involved in the development and administration of this Contest (collectively the "Contest Parties"), and each of their officers, directors, employees and agents from any and all claims, damages, liability, costs and expenses arising in connection with or from my participation in the Contest, my acceptance of, the use or misuse by me or by my travel companions of the Grand Prize I have been awarded, or any portion thereof, and such use or misuse of my entry in the Contest including, without limitation, any claim that my entry infringes the proprietary interest of any party.

4. I hereby:

- a. declare that I am a legal resident of Canada who has reached the age of majority in the province or territory of my residence at the time of entry in the Contest and that I am not a person who, based on the Official Contest Rules and Regulations, is ineligible to enter or is disqualified from participating in the Contest or winning the Grand Prize; and
